

**OFFICIAL RULES FOR THE 2016 BENJAMIN MOORE  
NEW JERSEY WORKSHOP AND NETWORKING EVENT RAFFLE**

- Acceptance of these rules is a condition to entering the raffle. All decisions of Benjamin Moore are binding.
- You must: (i) be 18 years or older, (ii) possess a valid driver's license, (iii) be a licensed contractor, architect, or designer in good standing in your state of licensing, and (iv) work at a licensed construction, architecture, or design company to enter the raffle.
- **NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** Void where prohibited. All federal, state, local, and municipal laws and regulations apply.
- The raffle will be held on Thursday, September 22, 2016 at the Benjamin Moore New Jersey Workshop and Networking Event being held at Galloping Hills Golf Course, 3 Golf Drive, Kenilworth, NJ 07033 (the "Workshop and Networking Event").
- A raffle ballot is necessary to participate in the raffle. In order to receive a raffle ballot, you must register as a participant for the Workshop and Networking Event. There are two ways to register: (1) at <https://bmreg.seeddevs.com/nj> between 12:01am Eastern Time ("ET") on August 15, 2016 and 6:29pm ET on September 22, 2016, or (2) at the Workshop and Networking Event entrance desk between 4pm ET and 6:29pm ET on September 22, 2016. You must provide all information requested during registration to receive a raffle ballot.
- After you register, you may claim your raffle ballot at the entrance desk at the Workshop and Networking Event between 4pm ET and 6:29pm ET on September 22, 2016.
- At the Workshop and Networking Event there will be five Benjamin Moore kiosks. To enter the raffle, you must fill out your raffle ballot; obtain a stamp on your raffle ballot from a Benjamin Moore staff member at each of the five kiosks; and leave the completed ballot with stamps from all five kiosks with a Benjamin Moore staff member at a designated ballot box desk set up by Benjamin Moore ("Ballot Box Desk"). You may enter the raffle between 6:30pm ET and 8:15pm ET. Only one (1) entry per person.
- You must fill in all of the information on the raffle ballot and obtain unique stamps from all five Benjamin Moore kiosks to be eligible to win. Benjamin Moore is not responsible for any lost, misplaced, illegible, incomplete or damaged raffle ballots.
- All entries will be sorted into two groups ("Groups"): an architect & designer group ("A&D Group"), and a contractor group ("Contractor Group") based on the occupation listed on the raffle ballot.
- The raffle will feature two drawings, one from each Group. There will be one winner from each Group.
- The drawings will take place at the Ballot Box Desk. At approximately 8:30pm ET, one ballot will be randomly selected from the entries in the A&D Group to determine an A&D Group winner. At approximately 8:30pm ET, one ballot will be randomly selected from the entries in the Contractor Group to determine a Contractor Group winner. Only one (1) prize per person.
- **RAFFLE ENTRANTS MUST BE PRESENT AT THE DRAWING TO WIN.** In the event a raffle ballot is drawn and the entrant is not present to win or is otherwise ineligible, additional ballots will be drawn until a winner is determined.
- A winner must present his or her driver's license to confirm his or her identity and eligibility after the drawing, and complete a W-9 form and other documentation as requested by Benjamin Moore. Benjamin Moore reserves the right in its sole discretion to disqualify any entrant or potential winner who violates these Official Rules, is not eligible or engages in any inappropriate or unsportsmanlike conduct in connection with the raffle.

- The prize for the A&D Group winner will be \$2,000. The prize for the Contractor Group winner will be \$2,000. The prizes are non-assignable, non-transferable, and not redeemable in cash. All taxes are the responsibility of the winner.
- In order to receive a prize, a winner must provide to Benjamin Moore, no later than October 22, 2016, a completed W-9 form (available at <https://www.irs.gov/pub/irs-pdf/fw9.pdf>) and a copy of his or her driver's license. All prizes will be issued to an individual and not to any company or entity. Each individual winner represents and warrants that he or she is authorized by his or her employer or company to accept any prize issued in connection with this raffle in his or her individual capacity.
- Benjamin Moore will mail each winner his or her prize, in the form a \$2,000 check, at the address the winner provided during registration. Benjamin Moore is not responsible for any lost, stolen, damaged or misdelivered checks.
- You consent to our use of your address to mail you your prize should you win.
- By entering the raffle, you warrant that the information supplied by you in connection with the raffle is true and accurate to the best of your knowledge and belief.
- Employees of Benjamin Moore and their family members (parent, grandparents, children, grandchildren, and siblings) and members of the same household of such employees are not eligible to participate in the raffle.
- The odds of winning depend on the number of eligible raffle entries received.
