  provided pre-addressed envelopes, include the redemption form with your store
  information, as well as the tear-pad sheets with the corresponding receipts/invoices.
- All redemption forms must be received by **December 31,2012**.
- Benjamin Moore will issue your credit in a lump sum at the end of the program.
   You can expect to see credit on or about February 28, 2013.

Credit applies only to eligible professional painting contractors' purchases made between 11/09/12 and 12/14/12 on one and five gallon sizes of Fresh Start® primer (\$4 off per gallon), Waterborne Ceiling Paint (\$4 off per gallon), and Moore's Muresco® (\$4 off per gallon) up to maximum purchase limit of 10 gallons per product, per contractor made in a single transaction ("qualifying purchase") in compliance with the applicable contractor discount offer terms and conditions. Retailers will receive a credit to their account.
