## 6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions** Remove all sources of ignition. Take precautions to prevent flashback. Ground and bond all containers and handling equipment. Take precautionary measures against static discharges. Ensure adequate ventilation. Avoid contact with skin, eyes and clothing. Use personal protective equipment.

## 7. HANDLING AND STORAGE
