- Although IARC has classified titanium dioxide as possibly carcinogenic to humans (2B), their summary concludes: "No significant exposure to titanium dioxide is thought to occur during the use of products in which titanium dioxide is bound to other materials, such as paint."
- Cobalt and cobalt compounds are listed as possible human carcinogens by IARC (2B). However, there is inadequate
 evidence of the carcinogenicity of cobalt and cobalt compounds in humans.
