Application:

ENTIRE SYSTEM SHOULD NOT EXCEED MORE THAN 4 MILS DRY. LENMAR® PRODUCTS ARE DESIGNED FOR INTERIOR USE, BY SPRAY APPLICATION ONLY.

Over properly prepared interior wood surfaces, apply one coat of Lenmar's® DuraLaq® Nitrocellulose undercoaters, 1C.358, 1C.365, 1E.410, 1C.216 or another approved undercoater. Spray out at 3-4 wet mils and in accordance with label directions. Allow to dry, then sand and topcoat with desired sheen level from the 1A.XX series DuraLaq® topcoats.

ENTIRE SYSTEM SHOULD NOT EXCEED 4 MILS DRY.

Specifications:

Moisture content of wood should be no higher than 9%. Wood must be free of surface contaminants. Final sand wood with 120-150 grit sandpaper, depending on species, and remove all dust. Apply undercoater according to PDS/label directions, allow to dry and sand with 280-320 grit silicon carbide sandpaper. Reduce desired topcoat with Lenmar's® 1A.519 Lacquer Thinner, as required, to achieve good atomization. Dilution may be at a rate up to a 3:1 ratio. Apply by spray only. Check with equipment manufacturer for proper settings to achieve optimal atomization. Small amounts of 1A.114 Lacquer Retarder may be necessary during adverse weather conditions. Read label and SDS for additional information and warnings.

Clean up with Lenmar's® 1A.519 Lacquer Thinner.
