When properly applied this product offers good initial build and excellent adhesion on properly prepared wood surfaces. This product sands easily and powders nicely to provide a smooth sealed foundation for follow-on coats. DuraLaq<sup>®</sup> 1C.203 is compatible with any Lenmar<sup>®</sup> nitrocellulose lacquer topcoat. It is not recommended for use over pickle finishes or white stains.

## Limitations

- It is not recommended for use over pickle finishes or white stains. Do not apply more than two topcoats.
- Entire system should not exceed 4 mils dry.

## Application

# ENTIRE SYSTEM SHOULD NOT EXCEED MORE THAN 4 MILS DRY. LENMAR® PRODUCTS ARE DESIGNED FOR INTERIOR USE, BY SPRAY APPLICATION ONLY.

Over properly prepared interior wood surfaces, apply one coat of DuraLaq<sup>®</sup> 1C.203, let dry, then sand. Topcoat with desired sheen level using any of the DuraLaq<sup>®</sup> Series Lacquers. For additional resistance to moisture and chemicals, try the following Lenmar<sup>®</sup> Finishing Systems: Ultra UniLaq<sup>®</sup> Acrylic 1M.97X series, UltraLaq<sup>®</sup> Precat 1D.33X series, or MegaVar<sup>®</sup> 1M.430X Series. Do not apply more than two topcoats.

## **Specifications**

Moisture content of wood should be no higher than 9%. Wood must be free of surface contaminants. Final sand wood with 120 to 150-grit sandpaper, depending on species, and remove all dust. Mix DuraLaq<sup>®</sup> 1C.203 thoroughly and reduce as necessary with Lenmar<sup>®</sup> 1A.519 or 1A.406 lacquer thinners, to achieve proper atomization. Apply one coat at 3-4 wet mils, allow to dry, then sand with 280-320 grit silicon carbide sandpaper. Select the sheen required from any of the DuraLaq<sup>®</sup> Series products, mix well and apply at least two coats. These products may be reduced with 1A.406 or 1A.519 or use 1A.114 retarder if necessary to prevent blushing. Do not reduce if doing so would violate any VOC regulations. Check with equipment manufacturer for proper settings to achieve the optimum atomization. Read label and SDS for additional information and warnings.

## Clean Up

Clean equipment with Lenmar® 1A.406 or 1A.519 Lacquer Thinner.
